So far, you have not proven any crime or criminal conspiracy. You have merely made unproven accusations which amount to defamation.

1. How is it possible that you, after a long, close relationship with her, couldn't know that her qualifications were fake?

The members of our executive are not employed, they volunteer their service to the Alliance. SAPRA does not, and is not required to initiate background checks on prospective members of this Alliance. The only qualification of membership to SAPRA is religious affiliation.

You have yet to prove your allegation that said qualifications are fake. I suggest you follow this accusation up with the HPCSA, not SAPRA.

2. Please will SAPRA and SAPC provide me a short statement (or press release) by 3pm, today - Monday, July 24 2017.

I provided this in my first response. You deliberately chose to ignore it by claiming that I was being evasive, simply because my response did not fit the false narrative you are attempting to pass off as true, without any substantive evidence to support your false assertions.

3. Why is the SAPC and SAPRA unconcerned at being provided evidence of crime. Why does an executive council member's fraudulent qualifications mean nothing to you?

You have not provided any such evidence, merely made unsupported defamatory accusations.

4. Answer point 3 in your personal capacity too.

Herman van Niekerk will be sending you evidence of completed investigation in due course regarding allegations made against Retha and against Maritime Risk Solutions.

Hi, Damon. as you've been a FB supporter for the past two years, you know what i do. That makes my sending of this email ironic and awkward. Nevertheless, i go where the story goes.

I'm investigating Retha van Niekerk and her husband, Herman van Niekerk, for fraud. Part of that concerns their fake qualifications.

You are friends with Retha. More importantly, she is an Executive leader in your South Africa Pagan Rights Alliance (SAPRA), even having stood in for you, as Director, when you were ill for an extended period of time in 2015. Additionally, she is SAPRA's marriage officer and, under SAPRA's banner, hosted her daughter's marriage to Vaughn Smit, an employee in their illegal company (Maritime Risk Solutions). Furthermore, like you, she was a founding member in South African Pagan Council's (SAPC) switch from NPO to registered religious organisation.

Online and in submissions to government (regarding pagan rights), you've presented Rhetha as a doctor and a psychologist (which, arguably, lent credibility to SAPRA). However, she is neither doctor or psychologist.

- 1. How is it possible that you, after a long, close relationship with her, couldn't know that her qualifications were fake?
- 2. Please will SAPRA and SAPC provide me a short statement (or press release) by 3pm, today Monday, July 24 2017.

Note that i'm providing you the opportunity to get ahead of this story which i will be publishing on Tuesday. My goal is to investigate fraud, not damage your organisation. Please cooperate with these things in mind. I don't wish to pursue SAPRA or the SAPC.
